PROCLAMATION – Law Enforcement Officers Week – May 13 – 19, 2012.

The professional law enforcement officers of Henrico County serve our citizens daily, protecting lives and property while upholding County ordinances and Virginia laws. By the nature of their duties, these professionals endure grave danger and, on occasion, loss of their own lives. This proclamation recognizes May 13 – 19, 2012 as Law Enforcement Officers Week and Thursday, May 17, 2012 as Law Enforcement Officers Day; encourages Henrico citizens to take note of these special dates; and salutes the County's law enforcement officers for their steadfast commitment to the County's public safety efforts and for their ongoing contributions to the quality of life of this community. The proclamation will be presented to the Chief of Police on May 17, 2012, during the County's annual Police Memorial Ceremony at Police Memorial Park.

RESOLUTION - Appointment of Members - Finance Board.

RESOLUTION - Award of Construction Contract - Glen Allen Softball Complex - Field Repair - Fairfield District.

This resolution awards a construction contract to **Enviroscape**, **Inc.** in the amount of \$346,000. The project consists of rehabilitation of the four existing softball fields at the Glen Allen Softball Complex, including applying root zone soil amendments, laser grading, sod installation, new irrigation systems, associated site work, and erosion and sediment control measures. The contractor shall achieve substantial and final completion no later than 42 days and 72 days, respectively, following the issuance of the Notice to Proceed. On-site con-

struction work will begin August 20, 2012. The softball field complex will be closed during the fall of 2012 to accommodate this project.

The County received four bids on April 3, 2012 in response to IFB #12-9216-3CE and Addendum No. 1, as follows:

The Directors of Recreation & Parks and General Services recommend that the Board award a contract in the amount of \$346,000.00 to Enviroscape, Inc. as the lowest responsive and responsible bidder, and authorize the County Manager, or the Director of General Services as his designee, to execute change orders not to exceed 15% of the original contract amount. The County Manager concurs. Funding to support the contract is available within the project budget.

RESOLUTION – Adoption of Policies and Fees Governing the Use of Elko Community Center – Varina District.

The purpose of this Board paper is to adopt a Facility Reservation Guide governing the use of the Elko Community Center located at 6216 White Oak Road in Sandston.

Elko Community Center was donated to the County by the Windsor Club of Elko in December 2011. It will be available for rental use beginning June 4, 2012.

The building rental fee will be based on the existing fees for Hunton Community Center which is comparable in building size and room layout. The use policy will be the same used in other recreational facilities operated by the Division of Recreation and Parks.

RESOLUTION - Signatory Authority - Lease Amendment - Department of Mental Health and Developmental Services - Charles City County, Virginia.

This resolution authorizes the County Manager to execute a lease amendment between Robert W. Peay and the County for the lease of 6,850 square feet at 205 Roxbury Industrial Center, Charles City, Virginia. The space is leased for the Cypress Enterprises day support and workshop program of the Department of Mental Health and Developmental Services for persons with intellectual disabilities living in eastern Henrico County and Charles City and New Kent Counties. The current lease expires on August 31, 2012 with an annual rent of \$36,852. The amendment would extend the lease for an additional five years at an annual rent of \$38,694.60. The Directors of Mental Health and Development Services and Real Property recommend approval of this Board paper, and the County Manager concurs.

RESOLUTION - Signatory Authority - Lease Amendment - Department of Mental Health and Developmental Services - 8237, 8239, 8241, and 8247 Hermitage Road - Brookland District.

This resolution authorizes the County Manager to execute a lease amendment between Staples Mill Business Center, LLC and the County for the lease of 27,295 square feet of office warehouse space located at 8237, 8239, 8241, and 8247 Hermitage Road. The space is used for the Hermitage Enterprises day support and workshop program for persons with intellectual disabilities.

This amendment will extend the lease for five years beginning March 1, 2013. Annual rent under the existing lease is \$206,535.60. Annual rent under the amendment would be \$200,520.00 in the first year and would increase 2% each year thereafter.

The Directors of Mental Health and Developmental Services and Real Property recommend approval of this Board paper, and the County Manager concurs.

RESOLUTION - To Permit Additional Fine of \$200 for Speeding on Sadler Grove Road from Sadler Road to its Terminus in a Cul-de-Sac.

Section 46.2-878.2 of the Code of Virginia provides for the imposition of a \$200 fine for speeding, in addition to other penalties provided by law, when a locality has established a maximum speed limit for a highway in a residential district and the speed limit is indicated by appropriately placed signs. The law requires the Board of Supervisors to develop criteria for the overall applicability for the installation of the signs and to specify application of the law to particular streets before the additional fine may be imposed.

On February 10, 2004, the Board approved criteria for the County's Traffic Calming Program.

The County's Traffic Engineer has collected traffic data and has determined that Sadler Grove Road from Sadler Road to its terminus in a cul-de-sac is experiencing speeding problems and meets the criteria for traffic calming measures set forth in the Traffic Calming Program.

The citizens in the area of this road requesting the increased fine have collected signatures from 78.3% of the residents.

The Board paper authorizes the County Manager to place appropriate signs on Sadler Grove Road from Sadler Road to its terminus in a cul-de-sac warning of an additional fine of \$200 for speeding.

The Director of Public Works recommends approval of this Board paper and the County Manager concurs.
