92-10 C-31C-09 Varina White Oak Crossing Acquisition, LLC: Request to conditionally rezone from A-1 Agricultural District, R-5 General Residence District and M-1 Light Industrial District to R-5C General Residence District (Conditional) and M-1C Light Industrial District (Conditional), Parcels 811-719-8863, 812-719-1130, 811-718-1589 and part of Parcel 813-720-9405, containing approximately 30.9 acres, located at the northwest intersection of S. PUBLIC HEARING ITEMS

105-10 Resolution – Real Estate Tax Levies, 2010.

John Vithoulkas, Director of Finance, noted that the proposed real tax rate would represent no change from the calendar year 2009 tax rate and that the average residential taxpayer in the County would actually see a real estate tax decrease this year because of the overall reduction in the assessed value of real estate in the County. Mr. Vithoulkas further noted that 2009 was the first year since 1942 that real estate valuations in the County had declined. The reductions in 1942 were not a result of the market but of annexation by the City of Richmond.

In response to a question from Mrs. O'Bannon, Mr. Vithoulkas explained how the County would be able to maintain the same tax rate without reducing services. Among the factors he cited were the collective wisdom of the longest serving Board of Supervisors in Virginia, the experience of the longest serving County Manager in Virginia, and the collective wisdom of County department heads as well as limiting expense growth during an economic expansion, budgeting revenues very conservatively over many years, refinancing outstanding debt at lower interest rates, and continuing the Henrico address initiative. Mrs. O'Bannon acknowledged the role of County department heads in cutting their budgets and expressed appreciation for their efforts. Mr. Kaechele commented that the Board was proud and pleased at the way the County manages its resources and for providing just as much with fewer resources. He thanked the County Manager, Finance Department, and Office of Management Budget for setting a good record.

No one from the public spoke in opposition to this resolution.

On motion of Mr. Glover, seconded by Mr. Thornton, and by unanimous vote, the Board approved this item – see attached resolution.

Resolution – Personal Property, Aircraft, Manufactured Homes, Qualifying Vehicles Owned or Leased by Members of a Volunteer Rescue Squad or Volunteer Fire Department, Disabled Veterans' Vehicles, Motor Vehicles Specially Equipped to Provide Transportation for Physically Handicapped Individuals, Machinery and Tools, and Machinery and Tools for Semiconductor Manufacturers Tax Levies, 2010.

Mr. Vithoulkas enumerated the various tax levies addressed by this resolution and noted that there were no proposed changes to any of these rates from the prior calendar year. He advised that these rates would allow the County to maintain its position of having the lowest tax burden among any full service local government in the Commonwealth of Virginia as measured annually in the independent survey referred to as the Chesapeake report. Mrs. O'Bannon commented that this

The Board recessed for dinner at 6:17 p.m. and reconvened at 6:39 p.m. Mr. Donati was not present during this portion of the meeting.

Mr. Hazelett reviewed the presentations and resolutions listed on the evening's regular meeting agenda. He noted that he had been interviewed by WTVR-TV 6 prior to this special meeting regarding the County's success with its Fiscal Year 2010-11 budget. The news media was very interested in learning how Henrico has fared so well in comparison to other localities and how it has avoided raising taxes. During the interview, Mr. Hazelett had pointed to careful planning by the Board and prudent financial decisions made by the County over the course of many years. Mr. Hazelett advised that staff would be requesting a 30-day deferral on one of the advertised public hearing items involving the purchase and leaseback of property at 8600-8604 Staples Mill Road because it was not yet ready for Board action. He referred to the seven condemnation resolutions on the agenda, which had been reviewed and discussed earlier at this special meeting during closed session. Mr. Hazelett suggested that if the media was present during the evening session the Board might wish to act on the resolution to adopt the County's annual fiscal plans for FY 2010-11 immediately following the public hearings and Board action on the two resolutions to establish tax levies for 2010. Doing so would require moving this resolution forward on the agenda. The Board concurred with this suggestion.

Mr. Hazelett and Mr. Rapisarda explained a resolution that Mr. Hazelett would be asking the Board to add to the evening's general agenda by unanimous consent authorizing the County to acquire property on Bacova Drive in the Three Chopt District. Mr. Hazelett and Mr. Tracy then responded to questions from the Board relating to the proposed acquisition of property at 8600-8604 Staples Mill Road, previous acquisitions of property by the County for the Government Center, the timing of constructing an access road from Staples Mill Road to the Human Services Building and expanding the parking lot serving the Juvenile and Domestic Relations Court Building, and the status of the Government Center's Henrico Federal Credit Union building. Mr. Hazelett commented that he would provide more information to the Board on the Government Center's master plan at a future work session.

There being no further business, the meeting was adjourned at 6:50 p.m.

WHEREAS, many Henrico residents choose recreational boating as a way to relax with their families and friends; and

WHEREAS, opportunities for on-the-water activities grow each year; and

WHEREAS, with this growth comes additional responsibility; and

WHEREAS, 5,486 of the 247,564 boats currently registered in the Commonwealth of Virginia are owned by residents of the County of Henrico; and

WHEREAS, additional boaters from outside the County visit our waters each boating season; and

WHEREAS, it is important that both novice and experienced boaters practice safe boating habits, maintain essential safety equipment, and wear a life jacket; and

WHEREAS, the law requires that a wearable life jacket be carried for each person on board all boats; and

WHEREAS, the life jackets of today are more comfortable, attractive, and wearable than the styles of the past; and

WHEREAS, the theme for the North American Safe Boating Campaign, "Wear It!", acknowledges that many lives are saved by the use of life jackets; and

The proposed ordinance would increase service and volume charges by approximately 5% for water and 5% for sewer, effective July 1, 2010. The total increase in water and sewer charges to a typical customer using 20 Ccf of water every two months will be \$6.10 bimonthly, or approximately 10.0¢ per day.

These changes are recommended to support the operating and capital budgets, including water and sewer rehabilitation projects.

The Director of Public Utilities recommends approval, and the County Manager concurs.

WHEREAS, the Board subsequently filed condemnation proceedings to establish the just compensation to be paid for the rights-of way and easements; and,

WHEREAS, the parties have agreed that the amounts previously paid by the Board to the Clerk of the Circuit Court and the additional amount of \$100,000 shall be just compensation for the property taken by the Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Henrico County that:

- (1) it authorizes settlement of the cases styled *Board of Supervisors v. Rebkee Replacement, LLC et al.*, Cases Nos. CL09-953 and CL09-2003, now pending in the Circuit Court of Henrico County, on terms as recommended by the County Attorney; and
- (2) the County Manager and County Attorney are authorized to execute all documents, in forms satisfactory to the County Attorney, necessary to conclude this case and implement the terms of the settlement.
